Total School Balances

The total school balances carried forward into 2021/22 are **£65,276.05**. This can be broken down into revenue balances, capital balances and community focussed balances as detailed below.

Revenue Balances

The total revenue balances (**B02**) carried forward into 2021/22 are **£56,356.82**. This represents **7.02%** of the total school revenue budget for 2020/21.
